## About Our ACLS Courses

The St. David's Institute for Learning offers the Advanced Cardiac Life Support 2-Day Provider Course for qualified healthcare professionals who have never taken the course before. The Renewal Course is a 1-day class providing a review and recertification to certified ACLS Providers. The AHA and St. David's Healthcare Partnership recommend recertification every 2 years.

Our ACLS Courses are taught according to the most current AHA Guidelines for Cardiopulmonary Resuscitation and Emergency Cardiac Care. Course materials may be picked up or will be mailed upon registration. ACLS class days run *approximately* 8:00 a.m. to 4:00 p.m. Participants must attend all sessions.

## Course Objectives

Upon successful completion of a Learning Center ACLS Course, participants will be able to:

- ✓ Verbalize role of BLS/ACLS in the management of cardiopulmonary arrest.
- ✓ Identify lethal/potentially lethal dysrhythmias and the hemodynamic consequence for each.
- ✓ Supervise/direct arrest team in a sequence that could lead to a successful resuscitation.
- ✓ Verbalize protocols for the treatment/management of dysrhythmias.
- ✓ Manage patient airway during resuscitation.
- ✓ Perform defibrillation/cardioversion safely and effectively.

### **IMPORTANT REMINDER**

## Prerequisites

### 2-DAY PROVIDER & RECERTIFICATION

- Participants must be medical, nursing, paramedic, or allied health personnel whose daily occupation demands proficiency in the knowledge and skills of ACLS.
- All registrants must be competent in **BLS Healthcare Provider** skills prior to attending ACLS training.

### 2-DAY PROVIDER ONLY

- Completion of a Dysrhythmia Interpretation course may be necessary prior to attending an ACLS course.

### RECERTIFICATION ONLY

- Participants must have been certified or recertified as an ACLS Provider within the past 2 years.

## Contact Hours

**2-DAY PROVIDER:** Participants who complete the evaluation tools and attend the entire course will be awarded 12 contact hours from the Texas Nurses Association.
